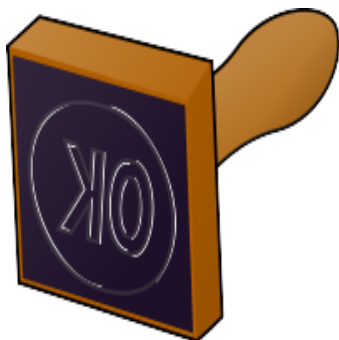




## Privacy statement



### About this privacy statement

Bureau De Paepe scsrl is committed to protecting the privacy of its customers and the visitors to this website, according to [the Belgian privacy law of 8 December 1992](#) [1]. We use the information we collect about you primarily to inform you about our products and services, and to provide a more personalized browsing experience when visiting this website.

### Your privacy

At Bureau De Paepe scsrl, we take your privacy and our responsibility to protect it very seriously. We have created this statement in order to demonstrate our firm commitment to making sure your personal information is safe and secure with us.

### What information do we collect ?

We collect information every time a visitor comes to this website. In order to access certain areas of this website, users are asked to register and provide us with certain information. This information may also be used for site customization and user profiling, and is stored into our databases.

### Use of IP addresses

When you visit this website, our web servers record your IP address and/or domain name. We use your IP address to help diagnose problems with our server and administer this website.

We also use your IP address to identify you, to track a user's session, and to gather other, non-customer specific demographic information. This information is used for statistical purposes only and





is analyzed to constantly improve the quality and accessibility of the information available on this website.

## Use of cookies

When visiting this website you may receive "cookies", small pieces of information that are stored by your web browser on your computer's hard drive. We use cookies to save information such as passwords and preferences so you don't have to re-enter it each time you visit this website, and to deliver content tailored to your interests.

Our cookies do not contain any personally identifying information, but they enable us to identify individual users for site personalization and to improve overall navigation. You may also be served cookies from our advertisers or sponsors while visiting this website. We do not control, nor do we have access to any of the information they may collect.

If you do not wish to accept cookies, most web browsers allow you to reject cookies. Please note, however, that if you choose not to accept cookies, you may encounter difficulties using certain parts of this website.

## How do we use this information?

We use the information we collect to occasionally notify you by eMail about important changes to this website, to introduce you to new products or services, to draw your attention to special offers from Bureau De Paepe scsrl, or to point you to other things we think you will find valuable.
